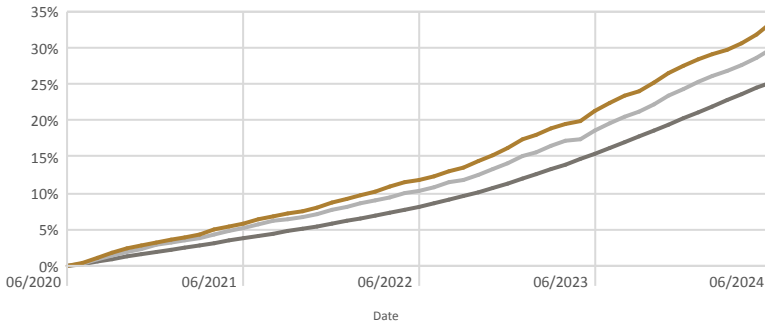
INVESTMENT OBJECTIVE

The Vunani BCI Short Term Fixed Interest Fund aims to provide investors with a higher return than a typical money market fund's return, while controlling risk and maintaining capital stability.

INVESTMENT POLICY

The investment manager will actively manage the investment opportunities. The following additional restrictions will apply: a minimum of 80% of interestbearing instruments will have a maturity of less than 3 years; a maximum of 20% of interest-bearing instruments will have a maturity of more than 3 years; securities with maturities exceeding 5 years will not be permitted; the weighted average modified duration of non-equity securities in the portfolio will not exceed 2 and there will be no exposure to equity securities. Investments to be acquired for the portfolio may include interest bearing securities, non-equity securities, money market instruments, bonds, fixed deposits, floating-rate notes and other suitable assets in liquid form. The portfolio may also invest in participatory interests and other forms of participation in portfolios of collective investment schemes. The portfolio may from time to time invest in listed and unlisted financial instruments.

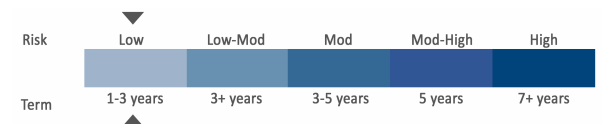
